Modifications to the Grant

Dear Mr Huizing

Reference is made to the Grant Confirmation dated 18 June 2018 (the “Grant Confirmation”) between the Global Fund to Fight AIDS, Tuberculosis and Malaria (the “Global Fund”) and the **Humanist Institute for Co-operation with Developing Countries (HIVOS)** (the “Principal Recipient”) for grant **CRI-H-HIVOS** (the “Grant”). Unless defined in this Implementation Letter or the context otherwise requires, all capitalized terms used in this Implementation Letter shall have the same meaning as set out in the Grant Confirmation.

We refer to Section 5.1 of the Grant Confirmation which provides that any cash left in the bank account under the Previous Grant Agreement after the start date of the Implementation Period shall immediately be transferred by the Grantee to the New Bank Account.

The Global Fund has identified an amount of remaining cash balance equal to **US\$231,838**. The Global Fund is therefore reducing the amount of Grant Funds set forth in Section 3.6 of the Grant Confirmation by this amount bringing the amount of Grant Funds referred to in Section 3.6 of the Grant Confirmation to **US\$1,888,259.91**. For the avoidance of doubt, the reduction of Grant Funds in Section 3.6 of the Grant Confirmation by the identified cash balance does not affect the Program budget, which remains unchanged.

In addition, we also note that since the date of signature of the Grant Confirmation, the Global Fund has moved offices. This change has also been reflected in Section 3.11 of the Grant Confirmation.

Pursuant to Section 12.3 of the Global Fund Grant Regulations (2014), in order to reflect the above, we would like to make the following changes to the Grant Confirmation:

1. Section 3.6 of the Grant Confirmation table has been updated as set out at Annex 1 of this letter.

Other than to the extent modified by this Implementation Letter, all provisions of the Grant Confirmation remain the same and continue to have full force and effect.

Please confirm your agreement to these amendments to the Grant Confirmation by signing this Implementation Letter and returning a copy to the Global Fund by electronic messaging system. These amendments will take effect upon the signing of this letter by Senior Manager of the Program Finance & Controlling Department indicated below. A copy of this letter will be sent to you for your records, by electronic messaging system, once the Senior Manager of the Program Finance & Controlling Department has signed the letter.

Thank you for your important efforts in the global fight against HIV and AIDS. We look forward to the continuing successful implementation of the Program.


